#### **Process**

The Longwoods Road Conservation Area – Tender T03-2024- Longwoods Road Conservation Area- Phase 2A Elevator, Washrooms, Gallery was issued on November 1, 2024 through Bids and Tenders and had 4 addenda associated with it. A mandatory site meeting was required for General Contractor submissions to be accepted, seven firms attended the meeting, four submissions were made. The closing date was November 27<sup>th</sup>, 2024 at 1:30pm, three attended in person and one requested to submit via digital submission due to unable to make it into the office on time based on geographic location, this requested was accommodated.

#### **Results of Tender**

Upon the closing time, four (4) firms presented their bids for the project. Those four (4) firms were:

The tenders were reviewed by Genevieve Champagne, Manager of Conservation Lands and Services. Each bid was reviewed for accuracy and completed in full.

The Tender came in higher than expected; however, with the Utility upgrade not required for Phase 2A and with the reduction of the contingency we can reallocate those expected funds to cover the overage associated with the Elevator Construction.

Tradition Construction Inc. is the recommended choice for proceeding with Tender T03-2024- Longwoods Road Conservation Area- Phase 2A Elevator, Washrooms, Gallery coming in at \$417, 200.00 (before HST), which is within the expected budget for the total costs for Phase 2A.

#### **Recommended Resolution**

**That** the Tender T03-2024- Longwoods Road Conservation Area- Phase 2A Elevator, Washrooms, Gallery project be awarded to Tradition Construction Inc for a total value of \$417,200.00 (before HST).

And that the CAO and Chair be authorized to sign contractual documents in this award.
